## Relief Committee - Tony Newton, Chairman

## A. Emergency Actions Since Last Post Meeting

The following emergency actions have been approved by the EXCOM. A motion for the post membership to concur with the action taken by the EXCOM will be brought forward.

1. The relief committee received a call from Ft. Loudon Hospital regarding the hospitalized widow of a deceased Korean war vet who fell at home and was taken by ambulance to hospital and is now ready to be released to home. She has an unsafe living environment and can't be alone. Her out of town daughter will return Friday night. Until then she needs a sitter for Thursday and Friday. The committee lead met with her, and she found a neighbor who is willing to be with the widow for the two days. The neighbor will take 2 days off work to sit. The committee is asking the post to pay the

neighbor \$100 a day to do this. Request is that the EXCOM approve up to \$200 for the sitter to drive the widow home and be with her for 2 days.

MOTION: That the Post membership concur with the EXCOM's emergency action decision to support this veteran's widow in the amount up to \$200 for the neighbor and sitter to drive the widow home and be with her for 2 days.

2. Relief Committee member John Lacko received a call from a VA case manager regarding a 70% disabled and unemployed Army veteran. He has a wife and 3 children and is behind in his rent almost \$5K. Vet has lived in the area since 2019, has held a number of jobs and for multiple reasons left all of them. He is originally from Houston, TX where he wants to go back to as he has family and contacts and is sure he can find work. The vet has PTSD because of his 2 tours in Iraq. He is working a payment plan with his landlord who is very understanding. He plans on leaving Knoxville late this month will stop in Nashville where his father-in-law will put better tires on his truck, and he will continue on Texas. He has arranged for a home to rent in Houston. Vet is requesting \$1,000 for gas and food during the trip.

MOTION: That the Post membership concur with the EXCOM's emergency action decision to support this veteran in the amount up to \$1,000 for gas and food for the vet and his family to get to Houston to reset his life.

## B. New Relief Actions to be Presented to the Post Membership

Received an email from CVSO Ron Hudson regarding a 100% honorably discharged and disabled veteran from a car accident whom we served in January 2023. At that time he and his wife were living in a 10' x 10' shed in his son's backyard with no water, facilities or heat and paying his son \$300/month. John Lacko successfully placed him in an apartment. At that time we partnered with VFW Post 5150 who paid two months rent and we paid \$859.87 for various fees, back electricity and security deposit. He has since been evicted. His living situation has improved in that his sister is giving him a trailer to live in . HE is on SSI receiving \$924/month and receiving no VA Services or money. He is asking for approximately \$700 to put brakes on his car which he needs for shopping and getting around. I received a call from Post 5150 Sr Vice Cdr Rob Knox suggesting we partner once again. Knox will speak with the repair facility to confirm the price.

MOTION: That the Post Membership agree to pay one half of the repair bill not to exceed \$500 While VFW Post 5150 has agreed to pay the other half.

## **Civil Air Patrol** – Dave

- This year, the TN State CAP Summer Encampment is held at Camp Hinsch, which is a pre-Ranger training facility. The Camp is in Tennessee located within the boundaries of the Ft Campbell Reservation.

This is the newest CAP Squadron in the State of Tennessee, and they are trying to send 13 cadets to summer encampment in July. This is the largest cadet participation by any Squadron in the State.

Most of those attending either are self-funded or did receive financial assistance from the National level CAP.

The two cadets that are in need of funding did apply for assistance from the National CAP

but were denied for lack of funds. The scholarship / assistance fund was exhausted by the time they were considered.

These two cadets (siblings - brother and sister) are enrolled in the "free and/or decreased school lunch program, as are many of the cadets in the Squadron. Their parents / family qualify for TN State food assistance.

The encampment fee is \$175 per cadet, so the request is for an additional \$350. These two cadets have uniforms and necessary uniform accessories (hat, rank, etc) that is either self-funded or funded by the CAP Squadron's funds.

MOTION: Request the post agree to fund an additional \$350 to the Sequoyah CAP Squadron (TN-330) to send these two cadets to the summer encampment, July 8-13, 2024.
