New Business

Relief Committee - Veteran Support Motions (Tony Newton)

- Emergency Action Funding Request
 - Discussion: Relief Committee Received a call from VA case manager John Boggs regarding an honorably discharged veteran who has been approved to move into subsidized housing on August 21, 2023. This 69 y/o Marine has been living in various motels for an extended period waiting to find an apartment and now to have it refurbished, inspected and approved. He has stage 3 lung cancer. He is 50% VA disabled, earns \$1900/mo from VA and SS. His motel bills have been paid by friends but they are no longer able to continue. He must move out Aug10 and find another place to live. He asks for 10 motel days which cost (\$675.54). The EXCOM approved this request, and the bill has been paid.
 - EXCOM approved an additional \$675.54 for this veteran.
 - Motion; A motion was brought forward by Ton Newton that the post membership support the EXCOM Emergency Action Decision to pay the Marine veteran's rent to the end of August in the amount of \$675.54 and that this emergency action does not preclude further action based on the need to act quickly.
 - The motion was seconded by Larry Dill. After a general discussion, **the motion was passed unanimously without further discussion or dissent.**
- Relief support to Veterans in VFW Post 12135
 - Discussion: Members of Tellico Village Post 12135 on occasion find themselves in a situation that requires some assistance for tasks or support due to a condition or situation beyond their control. In that light, members of this post should be treated and viewed the same as any veteran in the community this post helps according to post by-laws. Each situation requiring funding from the post will be brought before

the post membership as per the by-laws. The EXCOM may take emergency action as required as has been authorized by the membership.

- Motion: The members of Tellico Village Post 12135 be considered vererans of the community with regard to receiving assistance from the post, to include funding for tasks or services, that may be required due to unforseen conditions that require assistance.
- The motion was seconded by Larry Schaefer. After a general discussion, the motion was passed unanimously without further discussion or dissent

VFW Post 12135 Youth Outreach – BSA Support Program Motion (Otto Stutz)

- BSA Eagle Scout Plaque Funding
 - Discussion: VFW Post 12135 has established a Youth Outreach program where we sponsor three local BSA troops within Lenoir City. One aspect of this outreach program is where our VFW Post provides "recognition" to individual youths who achieve their highest honor Eagle Scout. Per previous VFW Post 12135 Membership approval, our Post has provided an engraved VFW Eagle Scout recognition plaque to each Eagle Scout from our Post. (Previous approval was cost NTE \$500 annually). Post has purchased past VFW recognition plaques from the same vendor we purchase our Post Golden Heart Awards. Our Youth Outreach BSA program lead requests to obtain funds to purchase the next block of 5 VFW Eagle Scout recognition plaques at a cost NTE \$300. The price for the Post will be approx. \$50-\$55 for each award totaling \$250.00 \$275.00 for 5 plaques.
 - Motion; A motion was brought forward by Shawn Tallant to support of our VFW Post 12135 2023-2024 BSA Program. The Motion asked to approve the funds NTE \$300 for the next block of VFW Eagle Scout Recognition plaques to be presented to our sponsored BSA Troops new Eagle Scouts
 - The motion was seconded by Dan Hall. After a general discussion, **the motion was passed unanimously without further discussion or dissent.**

VFW Post 12135 Exception to Post By-Laws Motion

- A Post By-Law exception request to hold December Meeting at Post CDRs residence.
 - Discussion: In order to promote camradere and fellowship amongst the menbers of VFW Post 12135, the post commander requested that the membership consider having the December Post meeting at the commanders residence. This will be a holiday social evet for the "good of the order."
 - Motion; A motion was brought forward by Shawn Tallant to make an exception to the Post by-laws and conduct the December Post meeting at the commanders esidence for the "Good of the Order."

• The motion was seconded by Rich Vimmece. After a general discussion, the motion was passed unanimously without further discussion or dissent.

Multi-County Veteran Resource Fair, 19 September (John Lacko)
